GPM Membership Payment Agreement Form

The Global Parliament of Mayors handles an annual membership fee based on the gross national income (GNI) and population of the applicant city. The undersigned authorises the Global Parliament of Mayors to send an annual invoice with the amount due during the time of membership. The annual invoice must be paid in full no later than two (2) months after it has been dated.

Revocation of this authorisation is done by cancellation or modification of the membership. If the undersigned city changes their membership, a new GPM Membership Agreement Form is to be signed.

If the undersigned does not agree with the membership fee calculated by the GPM, the city has the right to challenge this in writing by emailing the Secretariat at gpm@denhaag.nl with a detailed explanation. This must be received no later than two (2) weeks after the invoice has been dated. This will consequently be evaluated by the Executive Committee and Secretariat after which a formal decision will be communicated.
